Please find below details of your Management Charge liability for 2024 in Pounds Sterling or Euro.

We have carefully considered the rate of Management Charge for 2024, including the needs of the individual members and the requirements of the Club as a whole.

Due to the general inflation in the past year and its continuation into 2024, the base costs of running the resort will increase by 20%. However, we are aware of the difficulty members will have in coping with such a large increase.

So, we have created a package to absorb the impact of this year's 20% increase and provide a means of members generating funds to contribute to future management charges in two parts:

- There will be a dividend for current members to recognise the support given to your Club. This will be £105 per former week and has been deducted from the management charge. The net effect of this will be to absorb the inflationary increase for 2024.
- Access to the recently launched Crown Xtras platform, which is provided by Fizz Benefits and offers discounts and benefits. This will enable you to make savings on your shopping, holidays, entertainment and more and build up a cash balance in your Crown Xtras account which when withdrawn can be used to help you pay towards all or part of the following year's Management Charge.

To benefit from the Prompt Payment Rate, you need to pay in full by 31st December 2023. Payments received after 31st December but before 1st February 2024 (including monthly payments) will be charged at the Deferred Payment Rate.

If you wish to spread the cost, we offer the option to pay by Direct Debit in 12 equal monthly instalments in Sterling for members with a bank account in UK or Euro for members with a bank account in Spain. For further information please contact crownpoints@crownresorts.com.

Payments received after 31st January 2024 will be charged at the Late Payment Rate, so we do urge you to pay before then. Details of how you can pay are below.
